6. TERMS AND CONDITIONS

- a. The Applicant shall directly submit this Admission Form to the respective Authorized Training Centre (ATC) where he/ she intends to apply for the National Certification Programme for Rooftop Solar Photovoltaic Installer (the "Certification Programme").
- b. There shall be 3 (three) fees that the Applicant shall have to bear:
 - (i) <u>Application Fee</u> of Rs. 100/- (Rupees One Hundred Only) accompanied with this Trainee Admission Form to be submitted to the respective ATC where the Applicant intends to apply. The Application Fee shall be non-refundable.
 - (ii) Registration Fee of the amount determined by the respective ATC for undertaking the Certification Programme to be paid directly to the ATC once the Applicant is admitted to the Certification Programme (i.e. becomes a 'Trainee') by the ATC. The refund policy of the Registration Fee shall be guided by the ATC, which shall be clearly explained to the Applicant, and ATC shall undertake all direct and indirect responsibilities and liabilities towards such refunds.
 - (iii) Examination Fee of Rs. 3,000/- (Rupees Three Thousand Only) to be submitted to the ATC, which will be forwarded to GERMI by the ATC, for taking the final certification examination. GERMI shall undertake the final certification examination and provide the certification to successful Trainees.
- c. The Applicant shall be responsible to inquire about the deadline for a particular Certification Programme run by an ATC and submit his/ her application directly to the ATC before the deadline.
- d. The Applicant shall apply with the duly filled Trainee Admission Form with all necessary attachments and Application Fees to the ATC. Incomplete application may result into rejection of the application.
- e. Submission of the application does not automatically qualify the Applicant for the Certification Programme. The Applicant shall have to meet the basic qualification criteria for the Certification Programme as well as undergo the selection process of the ATC.
- f. The Trainee shall abide by all rules and regulations of the ATC, as amended from time to time, while undertaking the Certification Programme including but not limited to undertaking training whether within the ATC or outside, coursework, lab work, exercises, safety, attendance, examination, decorum and discipline.
- g. The ATC shall be directly responsible for the Trainee including but not limited to delivery of the training content, training facilities following rules and regulations, and so on. GERMI shall not be liable for any conflict whatsoever between the Trainee and the ATC whether directly or indirectly concerning the Certification Programme.
